# 11.3E Renewal of Student and Business System Software Maintenance Agreements for FY 2022 - 2026

PayPal e-commerce fees, invoiced separately as a pass-through cost by Ellucian, shall be based on actual transaction counts.

#### 11.3F Learning Management System ("LMS") Renewal

MOTION by DiMaria, supported by Vitale, that the Board of Trustees authorize the Administration to enter into a 36-month contract with Instructure of Salt Lake City, UT for the Canvas Learning Management System, subject to the approval of General Counsel, in an amount not to exceed \$769,307.86.

DISCUSSION: Trustee Flynn asked if we could find someone in Michigan for this, do we have to go to Utah? Dr. Sawyer said no, we can't find anyone in Michigan. This is a very specific product that takes a great deal of time and effort to implement. It is very specialized software and runs our whole online learning management system. It is significant and not something that can be priced out from different vendors with similar products, it is a major implementation. Trustee Flynn added that the next item is from Utah too, can't we find tables and chairs in Michigan? Dr. Sawyer said the board policy requires selection of the least expensive supplier meeting college specifications.

#### 11.3G Mity-Lite Tables and Table Carts

DISCUSSION: Trustee Flynn said there's nobody in Michigan that has tables and chairs? Trustee Cusumano said the point that Trustee Flynn makes raises this question, is the bid Freight on Board or is it a delivered price? Mr. Dennis Costello, Purchasing Director, said that is a delivered price. Trustee Cusumano said that was the only question he had about the logistical transport of something of volume from Utah to Michigan, a bidder could come in lower but the end cost to the user could be more than the next lowest bidder. Thank you, he appreciates the information. Trustee Flynn asked if they are coming by train? Mr. Costello said it will probably be over the road truck.
