## 11.2 Change Orders

#### 11.2A Change Order Request – Rehmann

MOTION by DiMaria, supported by Flynn, to approve a change order to the college's contract with Rehmann in the amount of \$6,500 for additional services required for the implementation of GASB Statement No. 96.

DISCUSSION: Trustee Dean asked what exactly is this for? EVP Argiri said this is a change order to the contract with Rehmann, the college's auditors, for additional hours they incurred for the implementation of GASB 96 that was not anticipated in their original contract approved by the board. Rehmann incurred 32 additional hours at a cost of \$13,000 and on behalf of the college she negotiated a share of 50 percent (\$6,500). This was an unanticipated increase because the pronouncement of GASB 96, that needed to be implemented this year for subscription-based IT arrangements, was not anticipated by her team either to be as involved as it was in terms of hours required to review three plus years of licensing for essentially capitalization and amortization.

#### 11.3C State of Michigan Grant Fund – Critical Incident Mapping

MOTION by DiMaria, supported by Vitale, to authorize Administration to enter into a contract, after review by the college's General Counsel, with The Critical Response Group of Ewing Township, New Jersey for critical incident mapping services in the total amount of \$319,865 from a State of Michigan grant fund.

DISCUSSION: Trustee Cusumano said the original amount of the grant was in excess of \$500,000, do we expend the \$319,865 and return the balance? Chief Bill Leavens said the award could only be used for mapping so the balance will be returned to the state following their process. Trustee Dean asked what is being mapped? Chief Leavens said this is mapping of the college property and all the buildings so emergency responders (fire, police) can go to the right location on campus. The Macomb County and City of Warren dispatchers along with the college's police and facilities teams will all be looking at the same mapping. This has been found to be best practice all across the country. The K12 districts had grants about a year ago and now they are available to community

colleges. The company is all former US military and this is the mapping used overseas that has proved to be successful with multiple forces that cannot even speak the same language but can operate together jointly. This has been brought to the civilian side so all first responders can come from multiple jurisdictions and disciplines and respond in an efficient way, making us so much more safer. Trustee Flynn asked how can you take a grant from the state of Michigan to New Jersey to get the work done? Chief Leavens said we went through the process and that company has a strong foothold in Macomb County. They have mapped 20 of the K12 schools here, they work with the Macomb County and Warren 911 dispatch centers, so it is critical that our mapping system talks with their mapping system with a well thought out process. They may be stationed out of New Jersey, but they are all US Military Veterans that have brought this technology here and started this company. Trustee Flynn just doesn't understand that you get the grant money and take it out of state. Trustee Cusumano asked if they will be drilling with the maps once they are executed with other law enforcement agencies and first responders? Chief Leavens said yes there are plans to do tabletops down the road with other jurisdictions. Trustee Cusumano said in your opinion it is reasonable and necessary for the safety and welfare of the students and staff and others using the facilities. Chief Leavens said yes, it is his highest recommendation.
