

Articulation Agreement

Between

This agreement is made this 17th day of January, 2018, by and between Macomb Community College and the following schools.

WHEREAS, the parties wish and intend by the Agreement to set forth the terms and conditions of engaging in an educational program to help eligible participating students continue their education toward an **Associate Degree in Early Childhood Studies/Teacher Cadet**.

Macomb Community College and listed High schools agree that students graduating from the Child Care/ Teacher Cadet program (CIP 19.0700/13.0000), who meet the following requirements will receive select credit in the Early Childhood Studies Associate Degree program (CIP 19.0708) at Macomb Community College.

- 1. Student must successfully complete their high school Child Care/ Teacher Cadet Program with an 80% ("B") average and an overall GPA of 2.0.
- 2. Student has received recommendation from high school Child Care/Teacher Cadet instructor.
- 3. Student must enroll in the Early Childhood Studies program at Macomb Community College within 3 years of high school graduation.

- 4. Course credit will be added to the student's transcript upon successful completion of Early Childhood Studies course(s) per this agreement. Regular tuition and fees for credit granted under this agreement will be waived.
- 5. Applicants for credit must meet all college admission requirements and be an enrolled/registered student in good standing.

Upon completion of ECHS-1100 and ECHS-1200 (with a grade of "B" or higher) in the Early Childhood Studies program at MCC, the student meeting these requirements will receive the following credit(s):

Students that have completed one year of the program at ABSD will earn: ECHS-1800-3 Credits Students that have completed two years of the program at ABSD will ear: ECHS-1800-3 Credits & ECHS-1810-3 Credits

These institutions agree to communicate concerning curriculum changes which affect the agreed upon relationships between articulated courses at the respective schools.

This Agreement constitutes the entire agreement between the parties, and all prior discussions, agreements, and understandings, weather verbal or in writing, are hereby merged into this Agreement.

No amendment or modification to this Agreement, including any amendment or modification of this paragraph, shall be effective unless the same is in writing and signed by all parties.

These agreements are housed within the Office of Secondary Outreach and posted on the college website.

This agreement expires June 30, 2019. The discard date is June 30, 2021.
