

Articulation Agreement

between

Macomb Community College

and

Chippewa Valley Public Schools

This agreement is made this 18th day of September 2014, by and between Macomb Community College and Chippewa Valley Public Schools.

WHEREAS, the parties wish and intend by the Agreement to set forth the terms and conditions of engaging in an educational program to help eligible participating students continue their education toward an Associate Degree in Information Technology – Applications Professional.

Macomb Community College and Chippewa Valley Public Schools agree that students successfully graduating from the Computer Information Systems Program (CIP 11.0201) at Chippewa Valley Public Schools who meet the following requirements will receive select credit in the Information Technology – Applications Professional Program (CIP 11.0201) at Macomb Community College.

1. Student must successfully complete Chippewa Valley Public Schools Information Technology Program with a minimum B average and an overall GPA of 3.0.
2. Student must successfully complete the following Microsoft Office Specialist (MOS) Certifications: Word, Excel, and Access.
3. Student has received recommendation from high school Information Technology instructor.
4. Student must enroll in the Information Technology program at Macomb Community College within 3 years of high school graduation.
5. Course credit will be added to the student's transcript upon successful completion of one of the following ITAP courses: (ITAP 1510, 1610 or 1710) at Macomb Community College. Regular tuition and fees for credit granted under this agreement will be waived.
6. Applicants for credit must meet all college admission requirements and be an enrolled/registered student in good standing.

In summary, students meeting the requirements of this agreement who:

1) Successfully Completed Chippewa Valley Public Schools Program:

(Information Technology Program and Microsoft Certification in Word, Excel and Access)

2) Successfully Completed ONE of the following MCC Courses:

- ITAP 1510 4 credits
- ITAP 1610 4 credits
- ITAP 1710 4 credits

3) Will Receive Credit for:

- ITCS 1010 4 credits
- ITCS 1400 4 credits
- *ITAP 1510 4 credits
- *ITAP 1610 4 credits
- *ITAP 1710 4 credits

(*Student will receive *College* credit for whichever ONE of the asterisked courses successfully completed and *Macomb College Articulated* credit for all other courses.)

These institutions agree to communicate concerning curriculum changes which affect the agreed upon relationships between articulated courses at the respective schools.

This Agreement constitutes the entire agreement between the parties, and all prior discussions, agreements, and understandings, whether verbal or in writing, is hereby merged into this Agreement.

No amendment or modification to this Agreement, including any amendment or modification of this paragraph, shall be effective unless the same is in writing and signed by all parties.

This agreement expires June 30, 2017. The discard date is June 30, 2018.
