

ARTICULATION AGREEMENT

between

Macomb Community College

and

Center Line Public Schools (18549)
East Detroit Public Schools (18765)
L'Anse Creuse Public Schools (17438)
Lapeer Education and Technology Center
Oakland Technical Schools
Richmond Community High School (20040)
St. Clair Technical Education
Utica Community Schools (17575)

This agreement, made this 13th day of September 2018, by and between Macomb Community College and Center Line Public Schools, East Detroit Public Schools, L'Anse Creuse Public Schools, Lapeer Education and Technology Center, Oakland Technical Schools, Richmond Community High School, St. Clair Technical Education, and Utica Community Schools.

WHEREAS, the parties wish and intend by the agreement to set forth the terms and conditions of engaging in an educational program to help eligible participating students continue their education toward an Associate Degree in Law Enforcement.

Macomb Community College, Center Line Public Schools, East Detroit Public Schools, L'Anse Creuse Public Schools, Lapeer Education and Technology, Richmond Community High School, St. Clair Technical Education Center, and Utica Community Schools agree that students graduating from their high school Law Enforcement program (CIP 43.0100) and who meet the following requirements will receive select credit in the Law Enforcement program (CIP 43.0103) at Macomb Community College.

1. Student must successfully complete their high school Law Enforcement program with a minimum 80% (B) average and an overall GPA of 2.0.
2. Student has received recommendation from Law Enforcement instructor.
3. Student must enroll in the Law Enforcement program at Macomb Community College within 3 years of high school graduation.

4. Course credit will be added to the student's transcript upon successful completion of two Law Enforcement courses with a grade of 'C' or better. Regular tuition and fees for credit granted under this agreement will be waived.
5. Applicants for credit must meet all college admission requirements and be an enrolled/registered student in good standing.


Upon completion of two courses in the Law Enforcement program at Macomb Community College with a grade of 'C' or better, the student meeting these requirements will receive 3 credits for LAWE 1100 -Criminal Justice.

These institutions agree to communicate concerning curriculum changes which affect the agreed upon relationships between articulated courses at the respective schools.

No amendment or modification to this Agreement, including any amendment or modification of this paragraph, shall be effective unless the same is in writing and signed by all parties.

These agreements are housed within the Office of Admissions & Outreach and posted on the college website.


This agreement expires June 30, 2020. The discard date is June 30, 2022.
